

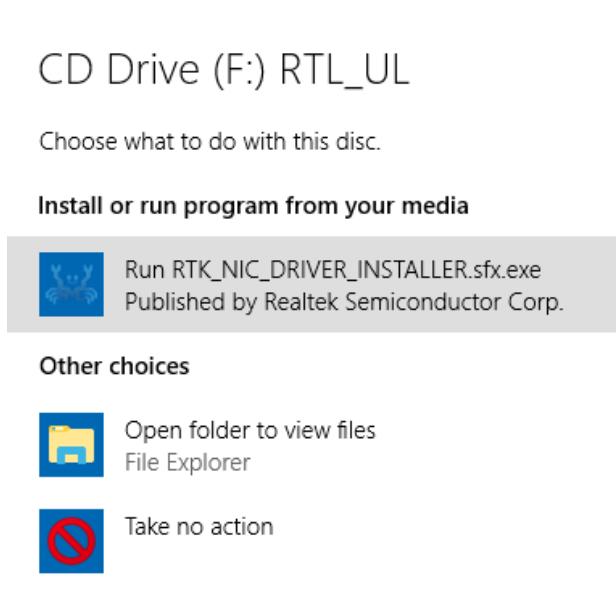



- Sluit de Ethernet Adapter aan op een lege USB type C poort op uw computer. Dubbelklik om de installer uit te voeren.





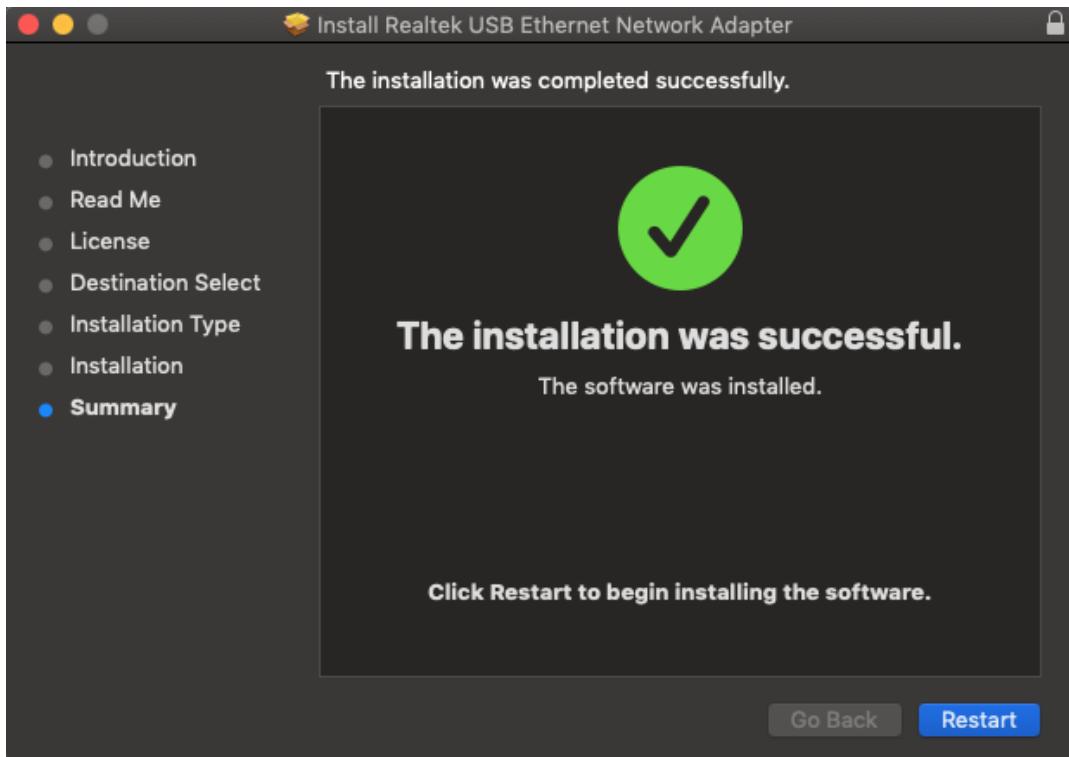






