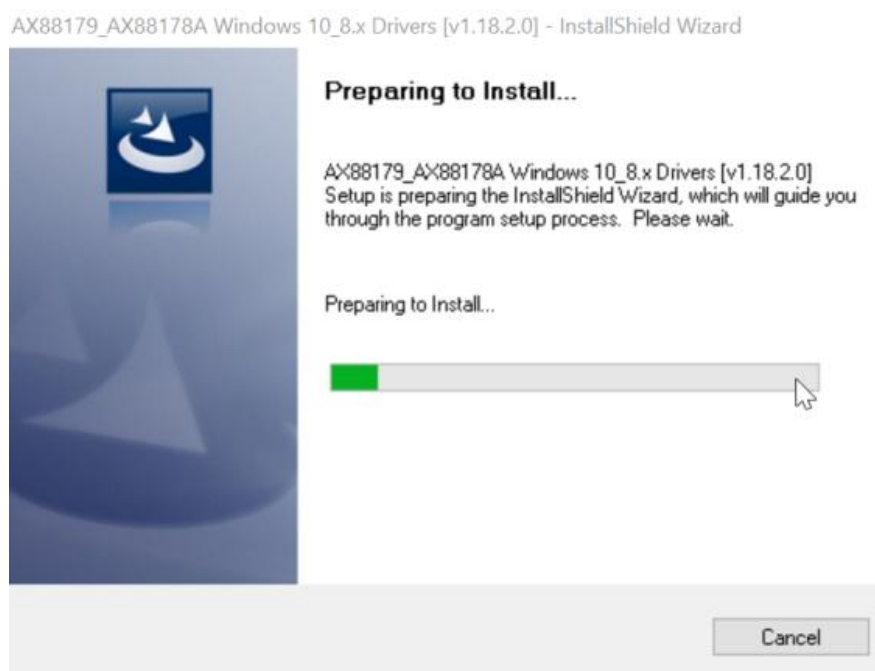

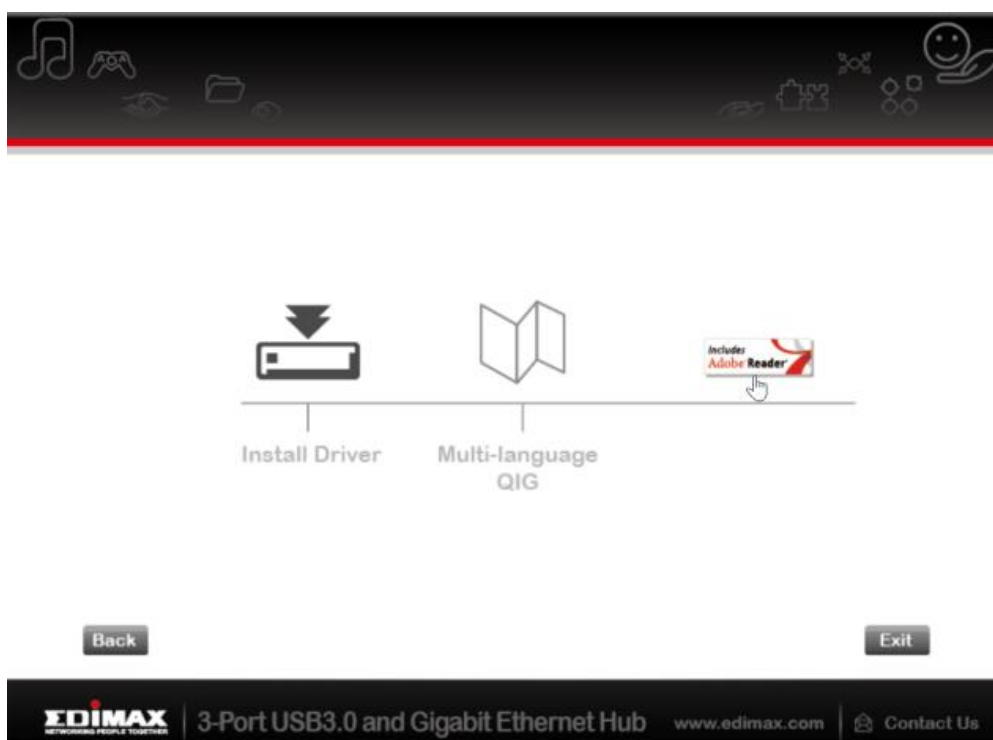

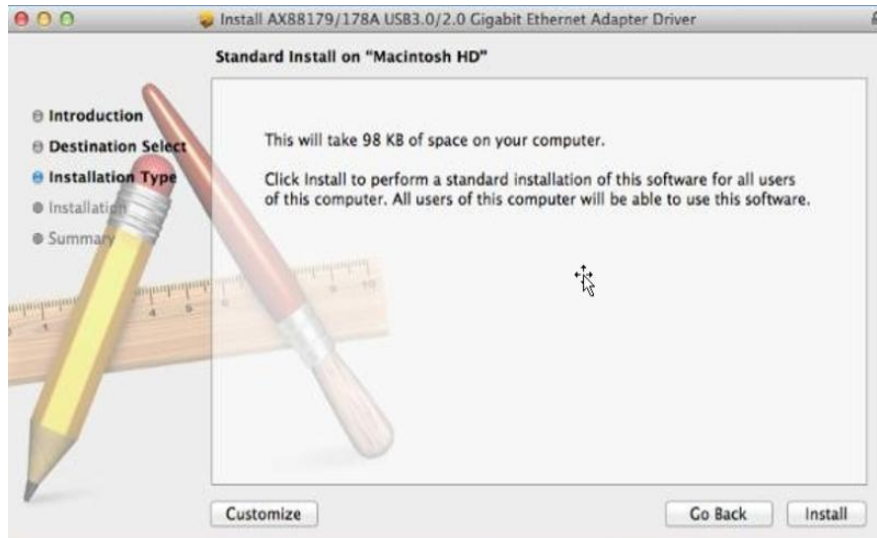

3. Klik på "Install" (installér) for at fortsætte installationsprocessen.



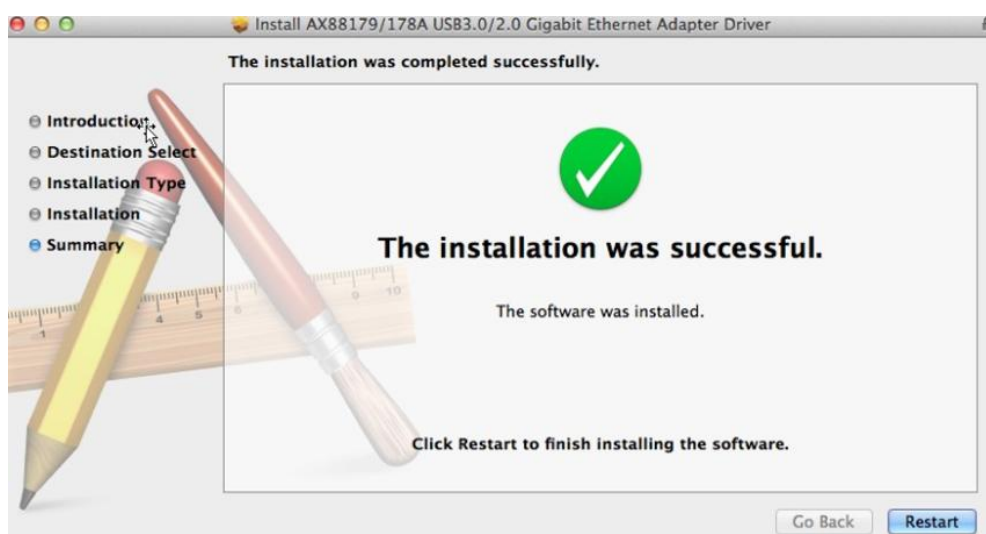

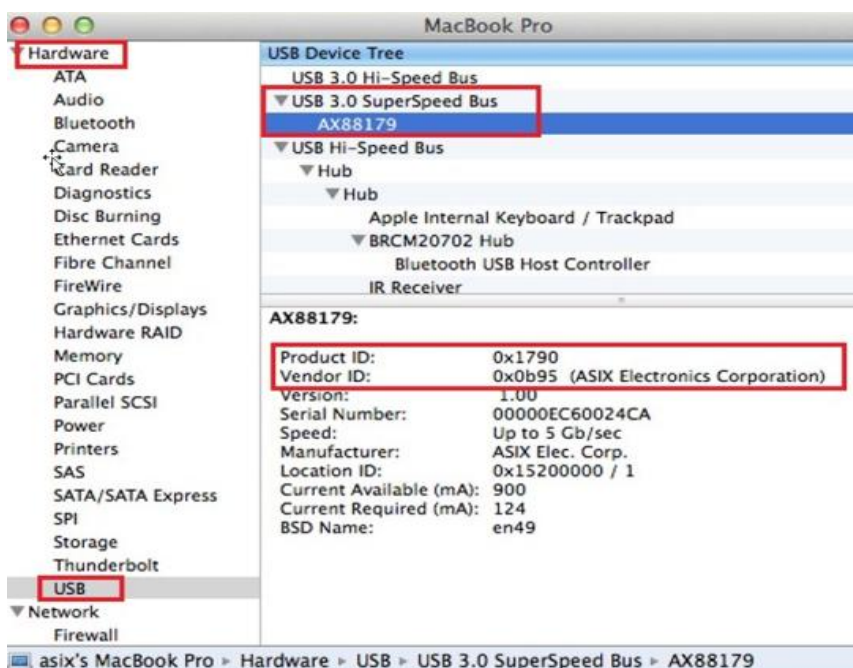

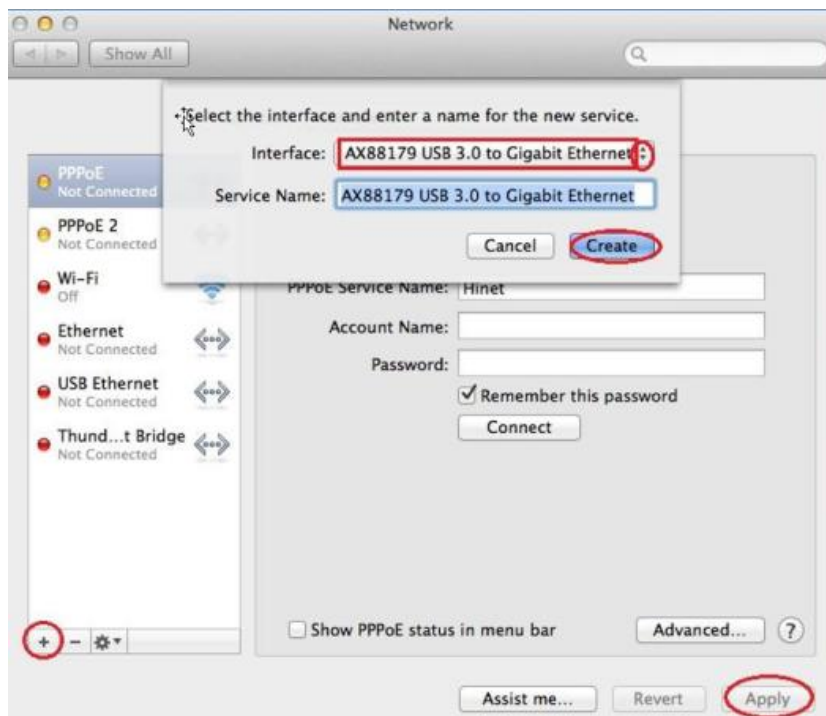

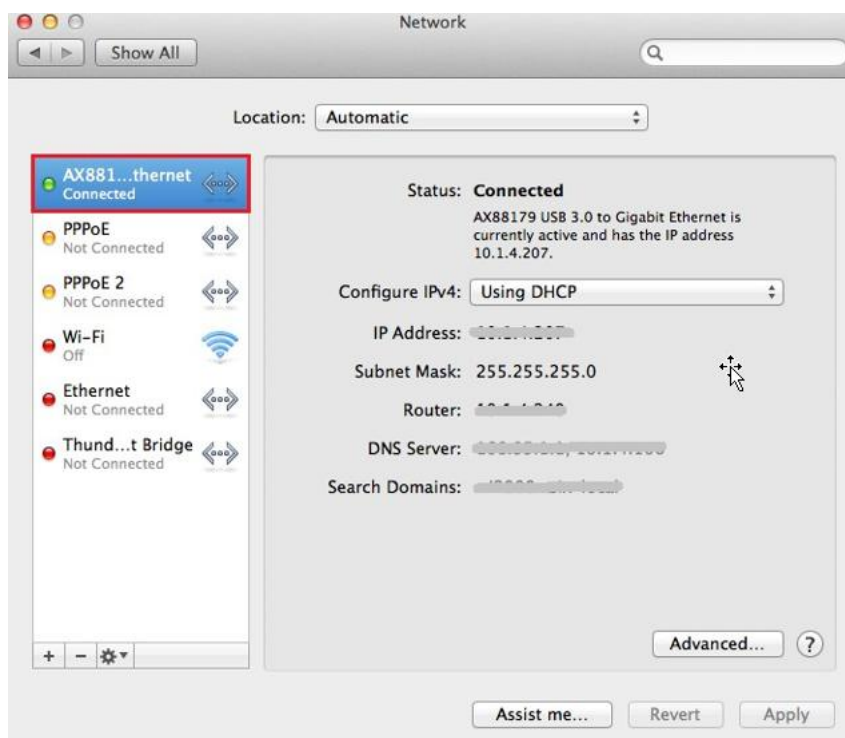
