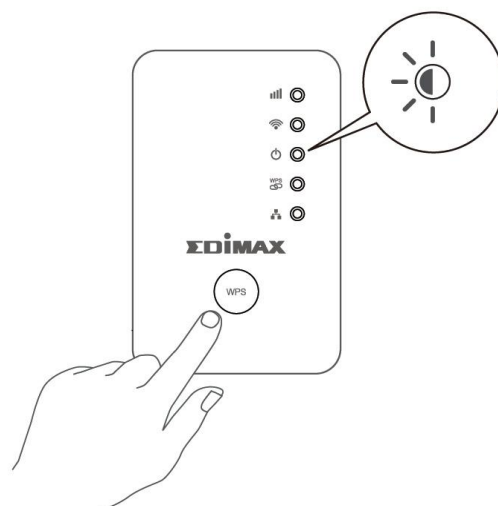


### III. Reimpostazione dell'unità di estensione

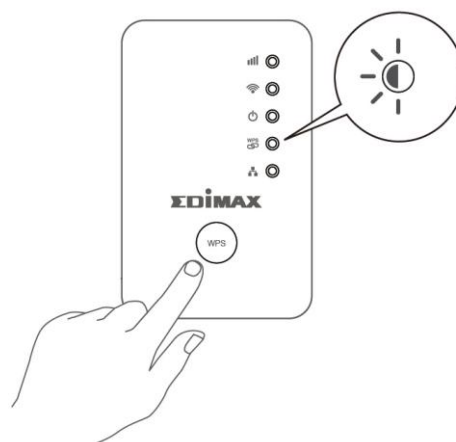
