

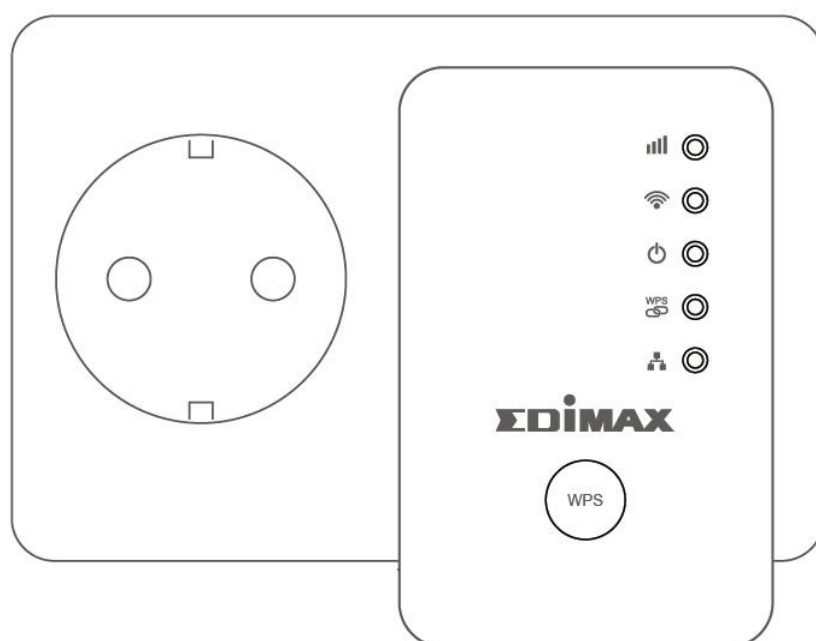

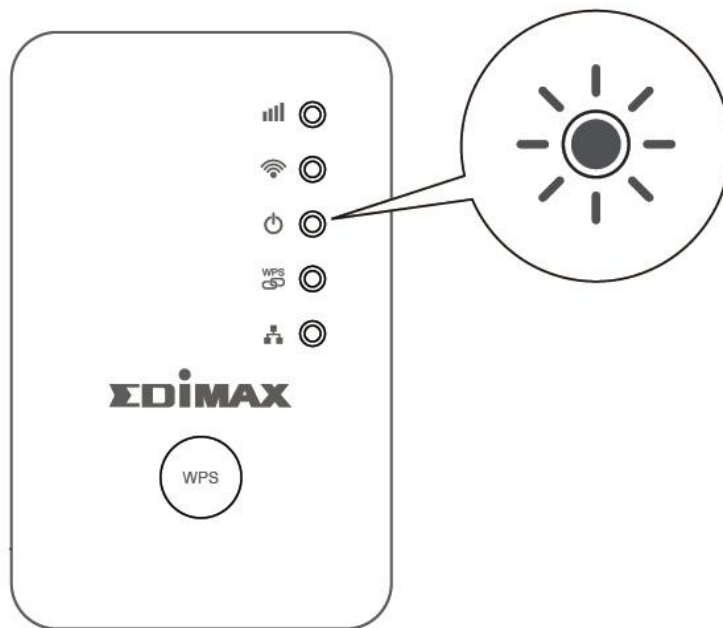
De EW-7438RPn Mini heeft drie verschillende modi:

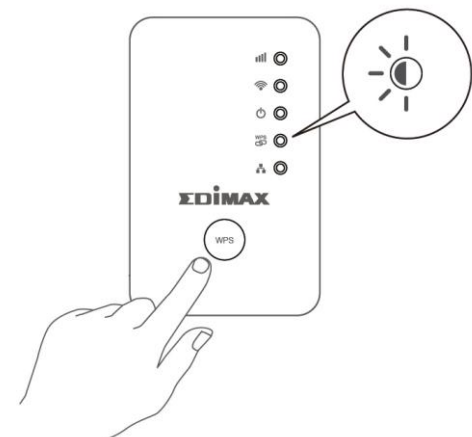
IV. WPS
