II-1. Insert the PCIe Adapter


1. Before inserting the PCIe Adapter, turn off your computer and unplug the power cord. Once the computer is power off, remove the case panel.




Ensure the power is off before you move to the next step.



2. Insert the PCIe adapter into the desktop PCIe slot. To use the Bluetooth function, connect the included USB Bluetooth header connector cable to the mother board and PCIe adapter respectively.



- **3.** There are two ways to connect the external antennas.
- A. Connect the antennas to the PCIe Adapter directly.
- B. Connect the external antennas with the included magnetic antenna base.



4. Reattach the case panel and power on your computer.

II-2. Download the Driver

Copy the driver to the USB flash drive first if you downloaded the driver on another Internet-Enabled device and insert the USB flash drive to the computer you will use the Wi-Fi USB adapter.

II-3-2-1. Wi-Fi Driver Installation

1. To install the Wi-Fi, once it's uncompressed fully, access the folder "WiFi" and click "WirelessSetup" to continue.




Notice that both Wi-Fi and Bluetooth drivers are in the same filename but in different folders.




2. Once the installation process starts, click "Next" to continue.



3. Read the License Agreement carefully. If you want to use the PCIe adapter, you must click on the "Checkbox" and then click "Install".



4. When the Wi-Fi installation is completed, click "Finish".



5. Please make sure your computer has been restarted before you go to next step.

II-3-2-2. Connect to a Wi-Fi Network


1. After you restart your computer, the Network icon will be displayed on the right-bottom Windows taskbar.



Notice that the Network icon might be different depending on your Operating System version.




2. For Windows 11 users, click the Network icon and then click the right-arrow icon to show the existing Wi-Fi Network (SSID) and select the one you want to connect. Move to step 4 if a password is required.



3. For Windows 10 users, click the Network icon to show the existing Wi-Fi Network (SSID) and select the one you want to connect.



4. Enter the password if it is required.



5. The Wi-Fi connection is established and you can access Internet when you see the Wi-Fi icon on the bottom-right corner of the Windows taskbar.




II-3-2. Bluetooth Pairing

II-3-2-1. Bluetooth Driver Installation


1. To install the Bluetooth, once it's uncompressed fully, access the folder "BT" and click "WirelessSetup" to continue.




2. Once the installation process starts, click "Next" to continue.



3. Read the License Agreement carefully. If you want to use PCIe adapter, you must click on "Checkbox" and then click "Next".



4. For the most common program features, recommend "**Typical**" for most users. Click "**Next**" to continue.



5. When the Bluetooth installation is completed, click "Finish".



You need to restart your computer to ensure make Bluetooth connection work properly.



II-3-2-2. Pair with the Bluetooth Device

1. Click the Bluetooth icon icon displayed on the bottom-right taskbar to pop up the menu. (If the Bluetooth icon doesn't appear, refer to III. FAQ -> Q2)




Notice that if the Bluetooth icon does not show up, click the arrow-up icon.




To activate Bluetooth without problems, please disable all existing Bluetooth devices first. (Refer to III. FAQ ->Q1).




2. Click "Add a Bluetooth Device".

4. Select the Bluetooth device in "Paired" status you want to pair with and click "Connect".


Q1. How to disable the existing Bluetooth device?

A. Right-click the Windows **Start** button **and**, and select the "**Device Manager**". Expand all the Bluetooth devices. Right-click on target device and disable the bluetooth device one by one.



Q2. Why doesn't the Bluetooth icon display on the Windows taskbar?

A1. Click Windows **Start** button and click "**Setting**" if , select "**Device** and other setting", and set the stauts as "**On**" to enable the bluetooth service.



A2. If the Bluetooth icon still doesn't appear, you may need to install the driver and try again. Please go to section III-2, to download and install the driver and try again.
