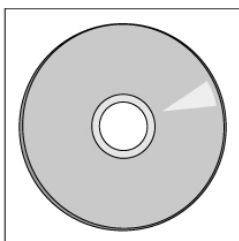

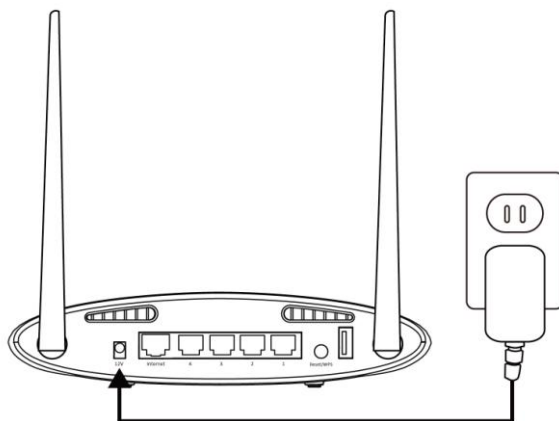

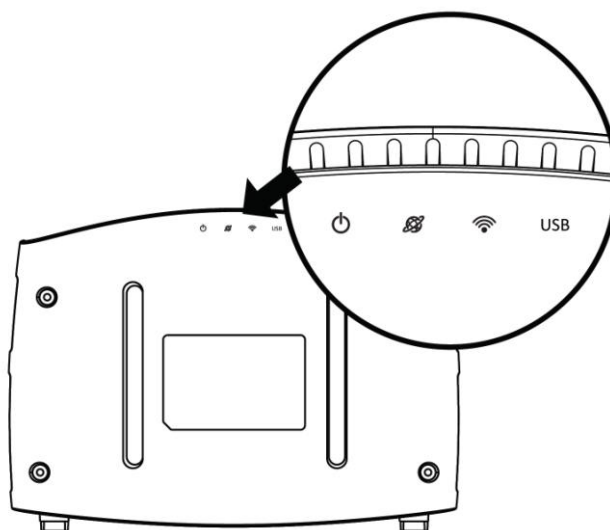
Adaptateur

Installation

1. Branchez l'adaptateur secteur fourni dans la prise d'alimentation 12V CC de l'appareil et branchez l'autre extrémité dans une prise de courant.



2. Vérifiez que le voyant d'alimentation s'allume.



3. Utilisez un périphérique Wi-Fi (ordinateur, tablette ou smartphone par exemple) pour rechercher le réseau Wi-Fi ayant le SSID "edimax.setup" ou "edimax.setup5G" puis connectez-vous à lui.



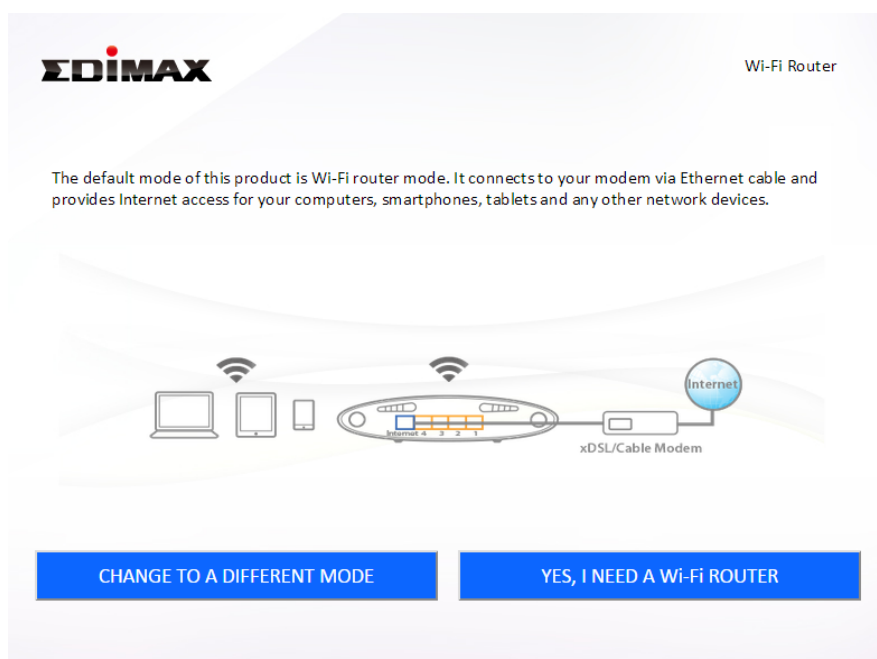
Les systèmes d'exploitation iOS 4 ou Android 4 et supérieurs sont nécessaires pour la configuration sur un smartphone ou une tablette.

4. Ouvrez un navigateur Internet et saisissez l'adresse ***http://edimax.setup*** si vous n'arrivez pas directement sur l'écran "Commencer" montré ci-dessous, puis cliquez sur "**Commencer**" pour démarrer la configuration.



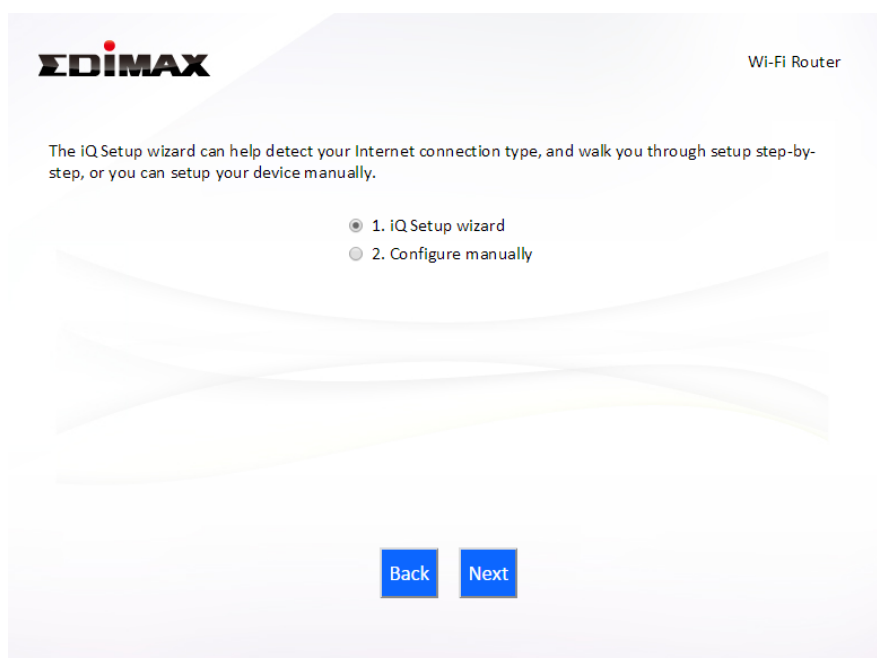

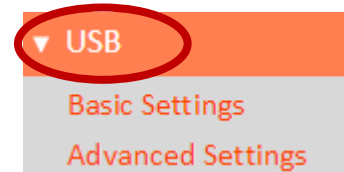
FAQs

1. Comment utiliser un dispositif de stockage USB ?

- a. Branchez votre dispositif de stockage USB dans le port USB à l'arrière du BR-6478AC V2. Le partage USB est activé par défaut de façon que les périphériques de votre réseau puissent accéder au disque de stockage USB en utilisant les outils appropriés pour votre système d'exploitation (ex : Explorateur de Fichier Windows → Réseau).



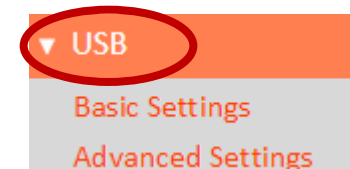
Les disques USB doivent être pré-formatés pour prendre en charge les systèmes de fichiers FAT32 ou NTFS avant de les brancher dans le port USB. Les hubs USB ne sont pas compatibles.



Pour obtenir plus de détails sur la configuration comme le partage de fichiers et le FTP, connectez-vous à l'interface de configuration Internet sur **<http://edimax.setup>** et accédez à USB dans le menu principal. Reportez-vous au manuel d'utilisation pour obtenir plus d'informations.

2. Comment partager une imprimante ?

- a. Accédez à **USB → Paramètres de base** sur **<http://edimax.setup>** et **activez** Partage USB puis sélectionnez **Serveur d'impression**.



Raccordez votre imprimante à l'appareil à l'aide d'un câble USB et assurez-vous que les pilotes de l'imprimante sont bien installés sur les ordinateurs avec lesquels vous souhaitez partager l'imprimante. Installez ensuite l'utilitaire Edimax Device Serveur Utility depuis le CD fourni (l'utilitaire peut aussi être téléchargé depuis **USB → Paramètres de base**).

3. Comment configurer un serveur VPN ?

- a. Un serveur VPN peut être utilisé pour disposer d'un accès déporté à votre réseau ainsi que pour plus de sécurité et de confidentialité. Connectez-vous sur **<http://edimax.setup>** et accédez à **Internet → VPN** pour configurer le serveur et consultez le manuel



d'utilisation pour obtenir plus d'instructions; Un client VPN comme OpenVPN est nécessaire sur votre périphérique réseau pour accéder au VPN de façon déportée.

4. Je ne parviens pas à accéder à Internet.

- Assurez-vous que tous les câbles sont correctement raccordés. Essayez avec un autre câble Ethernet.
- Vérifiez que vous pouvez accéder à l'interface de configuration Internet. Si ce n'est pas le cas, veuillez vous assurer que votre ordinateur est configuré pour utiliser une adresse IP dynamique. Consultez le manuel de l'utilisateur pour plus de conseils si vous n'êtes pas sûr de la marche à suivre.
- Connectez-vous à l'interface de configuration Internet et accédez à **Internet > Configuration WAN** puis vérifiez que le type de connexion est correct. Si vous n'êtes pas sûr(e) du type de votre connexion Internet, merci de contacter votre fournisseur d'accès Internet (FAI).
- Connectez votre ordinateur directement à votre modem et vérifiez si vous avez accès à Internet. Dans le cas contraire, merci de contacter votre fournisseur d'accès à Internet pour obtenir de l'aide.

5. Je ne parviens pas à ouvrir l'interface de configuration sur Internet.

- Veuillez vous assurer que votre ordinateur est configuré pour utiliser une adresse IP dynamique. Consultez le manuel de l'utilisateur pour plus de conseils si vous n'êtes pas sûr de la marche à suivre.

6. Comment puis-je rétablir les paramètres d'usine par défaut de mon appareil ?

- Pour réinitialiser les paramètres d'usine de l'appareil, maintenez enfoncée la touche WPS/Réinitialisation pendant 10 secondes jusqu'à ce que le voyant Internet commence à clignoter. Veuillez alors patienter quelques minutes que l'appareil redémarre. Tous les paramètres sont réinitialisés lorsque l'appareil redémarre. Les paramètres par défaut sont affichés sur l'étiquette à l'arrière du produit, comme indiqué ci-dessous :

7. J'ai oublié mon mot de passe.

8. Les ports bleu WAN et jaune LAN fonctionnent-ils de la même manière selon les différents modes de l'appareil ?

Non, les ports WAN et LAN possèdent des fonctions légèrement différentes selon le mode de fonctionnement de l'appareil.

- En mode **routeur Wi-Fi**, le **port WAN** sert à la connexion directe avec votre modem xDSL. Les **ports LAN** servent pour les clients réseau câblés.
- En mode **point d'accès**, le **port WAN** n'est pas utilisé. Connectez votre routeur existant au **port LAN** de l'appareil et les autres clients réseau câblés aux autres **ports LAN**.
- En mode **Amplificateur Wi-Fi, Pont Wi-Fi et FAISP**, le **port WAN** n'est pas utilisé et les **ports LAN** servent pour les clients réseau câblés. Ne connectez pas votre routeur existant aux **ports WAN** ou **LAN**, car cela pourrait causer un dysfonctionnement de l'appareil.

- c) Accompany it with the information you received as to the offer to distribute corresponding source code.
