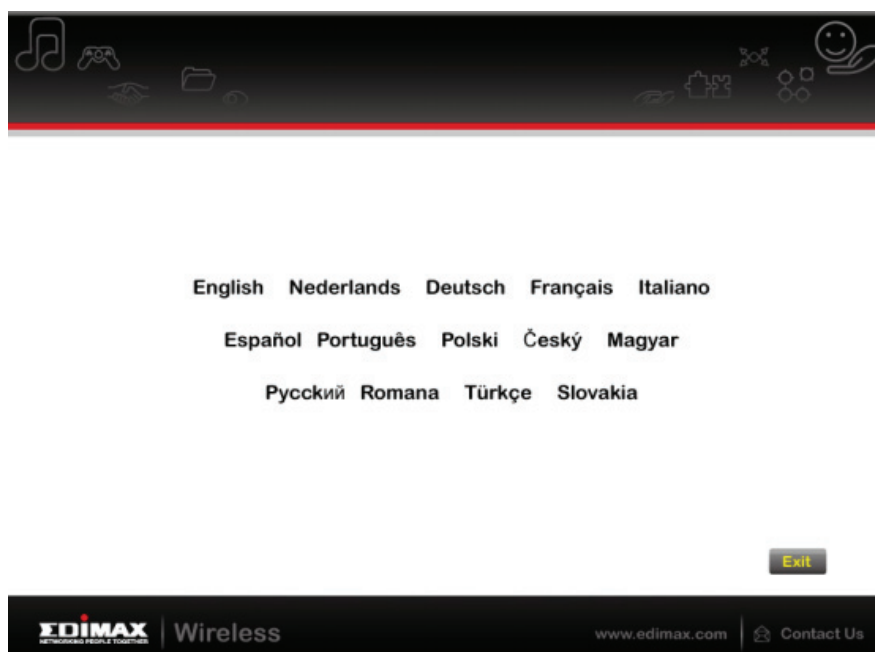
1. SWITCH YOUR COMPUTER OFF. Remove the computer cover and insert the wireless network adapter into an empty PCI Express slot.
