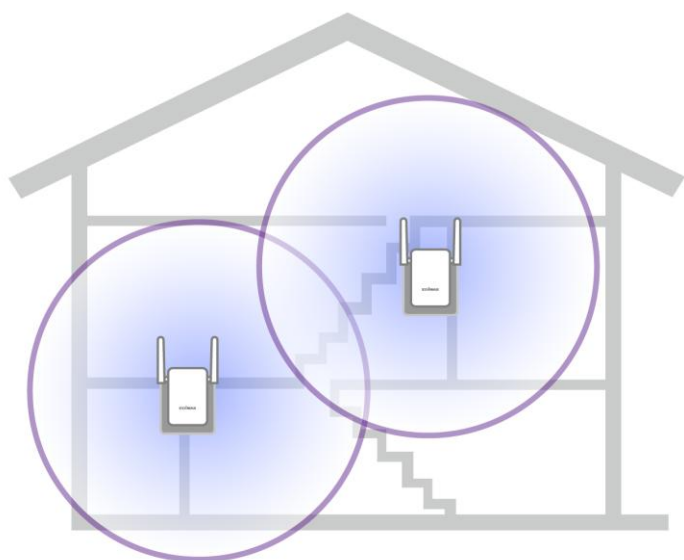

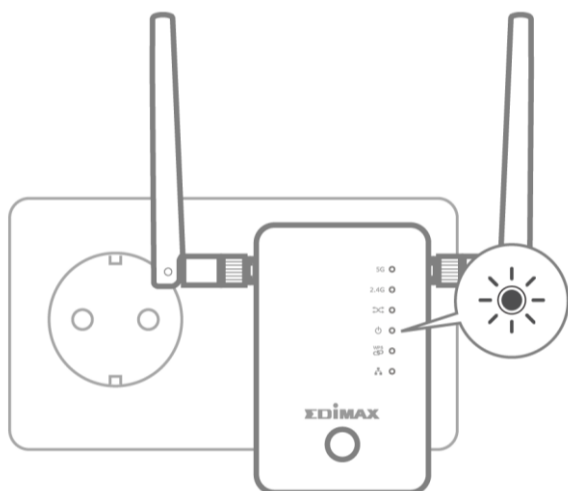

1. Jeg kan ikke se login-siden efter at have åbnet <http://edimaxext.setup> i browseren. Hvad kan jeg gøre?

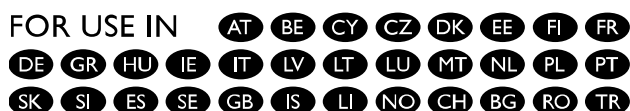
