Étape 3 : Passer le RE11S en mode Amplificateur :


1. Allumez le second RE11S en le branchant dans une prise électrique près du RE11S maître et patientez jusqu'à ce que le voyant d'alimentation s'allume.
2. Maintenez enfoncé le bouton WPS sur le RE11S maître pendant 3 secondes.
3. **Dans un délai de 2 minutes**, appuyez et maintenez enfoncé le bouton WPS sur le second RE11S. Les deux voyants 5G et 2,4G doivent clignoter.
4. La configuration est terminée dès que a) l'un des voyants clignote, ou b) seul un des voyants reste allumé.

Foire aux Questions (FAQ)

1. Je ne vois pas la page d'ouverture de session après avoir entré l'adresse <http://edimaxext.setup> dans mon navigateur, que faire ?

R : Pour remédier à cela, *tentez l'une des méthodes suivantes :*

- Testez et assurez-vous que votre ordinateur est bien connecté au réseau sans fil du RE11S.
- Testez et assurez-vous que votre ordinateur est configuré pour "Obtenir une adresse IP automatiquement" et pour "Obtenir une adresse de serveur DNS automatiquement".

2. Je ne parviens plus à accéder au RE11S. Je pense que j'ai saisi une phrase de passe ou une clé de sécurité incorrecte sur le RE11S pendant la procédure de configuration. (La sécurité de mon routeur est une clé WEP). Que faire ?

R : Le RE11S ne peut pas contrôler les phrases de passe WEP, alors si une phrase de passe incorrecte est saisie, votre périphérique sans fil ne peut pas obtenir la bonne adresse IP du RE11S. *Réinitialisez les paramètres d'usine par défaut du RE11S et recommencez la configuration.*

3. Comment puis-je rétablir les paramètres d'usine par défaut du RE11S ?

R : *Maintenez enfoncé le bouton WPS pendant au moins 10 secondes jusqu'à ce que le voyant d'alimentation se mette à clignoter lentement.*

4. Que faire si j'ai oublié mon mot de passe de connexion ?

R : Il n'existe aucun moyen de récupérer le mot de passe de connexion, *réinitialisez les paramètres d'usine par défaut du RE11S et recommencez la configuration.*

5. Quels sont le nom d'utilisateur et le mot de passe de connexion par défaut ?

R : Le nom d'utilisateur de connexion Internet par défaut est "admin" et le mot de passe est "1234".

6. Que faire si j'ai oublié mon mot de passe sans fil ?

R : Le nom de réseau sans fil et le code de sécurité définis par défaut en usine sont imprimés sur l'étiquette de l'amplificateur, si le mot de passe a été changé, *raccordez votre ordinateur au RE11S à l'aide d'un câble Ethernet et suivez les étapes ci-dessous :*


